

# CALL FOR RISIS COURSE TYPE A Joint and Open REsearch Programmes: features and potentialities of the JOREP database

CERIS-CNR, Rome – November 27-28, 2014

# This course is part of the Training Activities of the RISIS Project [http://risis.eu/training].

## **1. OBJECTIVES OF THE COURSE**

The course aims at introducing the features of the JOREP database, highlighting the specific contents and framing its potential uses in the context of the theoretical background on which have been designed.

More specifically, the course trains the participants to figure out and to address research questions on joint programming within the ERA, using the JOREP infrastructure.

*Examples of questions:* How relevant are joint programs in the ERA? What kind of integration do they realize? At what level? Which are the main actors involved and how they can be differentiated? How the participation to joint programs can be differentiated by country and disciplines? How skewed is the distribution of resources among joint programmes and what is its impact on the growth dynamics?

The presentation of the technical structure of the infrastructure will facilitate the learning of the techniques of consultation and querying. At the end of the course, the trainees will be able to handle the dataset, creating custom queries according to own research interests.

#### 2. GENERAL CONDITIONS FOR PARTICIPATION

2.1 Potential participants are expected to have interests in using large data sets and developing indicators in their respective areas of professional competence. Training will highlight the opportunities for the end-users, displaying several mode of exploitation of the JOREP dataset.

2.2 The course is addressed to:

- ✓ Senior scientists, early career researchers and PhD students at the last phase of their training;
- ✓ Officers from the policy making level (e.g. funding agencies);
- ✓ Research associations.

2.3 Participants will be asked to bring their PC (with MS ACCESS installed) when attending the course. Basic working knowledge of MS ACCESS and data querying are preferably required. Participants can send some preliminary questions about data handling in MS ACCESS in order to focus on specific topics related to the JOREP dataset.

**Maximum number of participants for the course is 15.** Participants will be selected on the basis of their interests and CV. Notification of acceptance and request of confirmation will be sent after the selection process is completed.
